Announcement on health examination activities undertaken jointly with the YG Health Insurance Society and covered establishments

YG Health Insurance Society

In principle, under the Act on the Protection of Personal Information, the provision of personal information to third parties requires the consent of the individuals in question. However, by law, cases involving ① provision to subcontractors; ② provision through merger or similar activities; or ③ joint use within a single group do not constitute cases of provision to third parties. The YG Health Insurance Society jointly uses health examination data in health examination activities undertaken jointly with covered establishments.

Accordingly, the Society hereby announces the following information as required by law: ① the fact of joint use; ② items of personal data subject to joint use; ③ the scope of parties involved in joint use; ④ purposes of use by those involved in joint use; and ⑤ the names of parties responsible for managing personal data.

1. Joint use of personal information in health examination activities with covered establishments

The Society undertakes health examination activities jointly with covered establishments (parent organizations) to optimize efficacy and efficiency in managing the health of insured persons (employees).

2. Items of health examination data subject to joint use

O Examination items including basic examinations, complete checkups designated by health insurance, one-day complete checkups, gynecological examinations, and brain checkups

(including health examination items specified in the Industrial Safety and Health Act [statutory examinations])

○ In addition to notification of the results of the above examinations and others, assessments of each item and overall assessments and guidance items

3. Scope of parties involved in joint use of health examination data

Staff responsible for health examinations in the YG Health Insurance Society and covered establishments

4. Purposes of use by parties involved in joint use of health examination data

• In accordance with the objectives of the Industrial Safety and Health Act, the sections responsible for supervising health examinations at the covered establishments strive to ensure the health and safety of workers in the workplace and to promote comfortable working environments. In partnership with the YG Health Insurance Society, they also strive to maintain and promote employee health so that employees can live healthy lives every day, even outside the workplace.

Specifically, health examination data is used to provide health consultations and health guidance services based on the decisions of and instructions issued by industrial physicians.

• In accordance with the spirit of Article 150 of the Health Insurance Act, the YG Health Insurance Society strives to maintain and improve the health of insured persons, together with the sections responsible for supervising health examinations at covered establishments.

Specifically, the Society retains health examination data on its computers and uses this data to provide health consultations and health guidance services under the direction of industrial physicians and health nurses. It also uses health examination data to identify and provide

health education to those who have or are at risk of developing lifestyle-related conditions.

5. Names of parties responsible for managing health examination data

The persons responsible for managing health examination data are the managers in the sections responsible for supervising health examinations at covered establishments and the Managing Director of the YG Health Insurance Society.
